by ripping off her clothes and throwing her onto the bed, where he began to choke her, hit her , and yell at her. Ms. Hil [REDACTED] stated in fear of being raped she attempted to push back Mr. Teague from being on top of her. Ms. Hil [REDACTED] stated she was able to get loose and attempted to run for the door, when Mr. Teague grab her and shoved her into another room. Ms. Hil [REDACTED] stated Mr. Teague would not let her leave, get dressed , or use her phone. Ms. Hil [REDACTED] stated Mr. Teague threatened her several times , stating " Shut the fuck up before, I smash your head in and I will end you tonight". Ms. Hil [REDACTED] also stated that Mr. Teague stated that he was going to call his ex-wife in Ohio to get him pissed off , so that he can take it out on her. Ms. Hil [REDACTED] stated Mr. Teague stated I'm am going to fuck you up, you don't know who your dealing with". Ms. Hil [REDACTED] stated through out all this Mr. Teague continuously slapped her, punched her and choked her , while yelling these threats to her. Ms. Hil [REDACTED] also stated Mr. Teague stated " I'll murder you", " I will smash your fucking head in, say one more thing".

Ms. Hil [REDACTED] stated Mr. Teague continued to refuse to allow her to get dressed or leave her apartment. Ms. Hil [REDACTED] stated Mr. Teague continued to drink alcohol and yell at her. Ms. Hil [REDACTED] stated Mr. Teague went into paranoid statements and attempted obtain access to her gun safe but distracted him by continuously asking to allow her to get dress. Ms. Hil [REDACTED] stated shortly after Mr. teague allowed her to put on a T-shirt. Ms. Hil [REDACTED] stated she was able to obtain her cell phone where she was able to text her friend to contact the police. Ms. Hil [REDACTED] stated shortly after police arrived and Mr. Teague was arrested. Ms. Hil [REDACTED] stated she would like to file charge in regards to false imprisonment and terroristic threats.
